Support	HB 1596 replaced gender-specific pronouns in dozens of state statutes with gender-neutral nouns.	Oppose
Support	HB 2789 <i>prohibits</i> restricting or removing objectionable books from all libraries, including school libraries.	Oppose
Support	HB 3093 requires tampons in <i>all men's public bathrooms</i> and \$100 fines if not kept filled.	Oppose
Support	HB 4867 makes it a crime to prevent anyone, including a minor, from getting an abortion.	Oppose
Support	HB 5239 prohibits imposing civil or criminal penalties on anyone who crosses state lines with a person (including a minor) seeking an abortion.	Oppose
