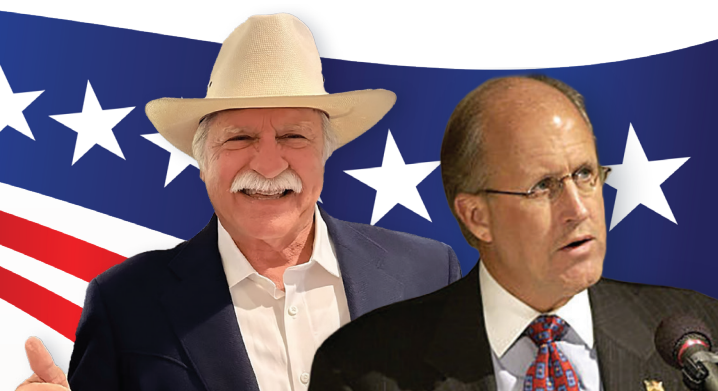

DAVID M. WALKER

Former Comptroller General of the United States

David “Dave” Walker is one of the nation’s leading experts on fiscal responsibility and government accountability.

- **The Ultimate Fiscal Watchdog:** As the former Comptroller General of the United States, he served as the head of the Government Accountability Office (GAO). In this role, he was the nation’s top auditor, tracking how federal tax dollars are spent and regularly warning Congress about the long-term dangers of America’s growing national debt.
- **Broad Leadership Experience:** His insights aren’t just limited to Washington. He brings decades of leadership experience spanning the private sector, government agencies, and non-profit organizations.
- **The Mission:** Having spent a lifetime analyzing the math behind our nation’s balance sheets, he focuses on non-partisan, math-driven, “common sense” fiscal stewardship to protect programs like Social Security before they hit a breaking point.

JOE PENLAND, SR. (“Joe from Texas”)

Business Leader, Author, and Advocate

Joe Penland, Sr. brings the practical, real-world perspective of a self-made American businessman to the stage.

- **A Lifetime of Business Leadership:** Known broadly as “Joe from Texas,” he is a family man, grandfather, and great-grandfather who built a highly successful career living the American Dream. He approaches national problems the same way a business owner approaches a balance sheet—with straight talk and practical accountability.
- **Champion for Practical Reform:** In his public advocacy and writings, Joe focuses heavily on structural issues in Washington that block real change. As he pointed out in his recent *Newsmax* piece, he believes a major reason Congress avoids fixing Social Security is the pressure of the endless reelection cycle.
- **The Solutions He Proposes:** Rather than waiting for a political crisis, Joe advocates for bold, structural fixes. These include implementing **congressional term limits** to give lawmakers the political courage to act, and establishing an **independent, bipartisan commission** (similar to the 1983 Greenspan Commission) to work out a lasting solution to protect benefits for future generations.

Why They Are Teaming Up

Together, Walker and Penland represent a powerful combination: the **Washington numbers guy and the Texas businessman**.

Their joint presentation is explicitly non-partisan. They aren’t trying to score political points; instead, they are using their combined private and public sector experiences to sound a “wake-up call.” Their goal is to cut through political theatre and advocate for sound financial planning, ensuring that the Social Security Trust Fund remains secure for American families well past its currently projected 2032 strain.
